If you work for a Dutch employer, or your contract is otherwise subject to Dutch employment law, there are a number of matters to think about when negotiating a contract. Collective agreements (cao). In many cases, employers are subject to collective agreements, or "cao's", which cover working conditions and benefits. Within the limits of the law, parties are free to decide what will be covered by the contract. Temporary contracts and indefinite contracts. Temporary contracts have a clear start and end date. The contract ends by operation of law at the given date, without notice or an official dismissal procedure needed. The role of the works council is becoming increasingly important, also in the area of employment conditions.
